Welcome to our annual *California Air Quality Awards*! We are thrilled you have joined us to celebrate those who are making tremendous strides in improving air quality.

Out of necessity for our health and well-being and that of our children, California has the most ambitious clean air goals in the nation. To achieve this vision, it is going to take a diversity of stakeholders. That is reflected here today. From philanthropy to industry to local and state government, our honorees are making our climate and air quality goals a reality.

There is no more important sector to the Coalition for Clean Air and our nonprofit partners than philanthropy. Grants from the William + Flora Hewlett Foundation have helped move us forward to improve air quality and fight climate change in ways we never even thought possible. Only 2% of foundation funding in the United States is spent on programs related to climate change. We are especially grateful that the Hewlett Foundation has chosen to focus on the mission of clean air and climate change.

Like philanthropies, local government agencies do not get enough credit in moving good clean air policies forward. For this reason, we are proud to recognize the Antelope Valley Transit Agency. The transit authority has committed to placing 13 electric buses – built by local labor – on the road with the hope of dramatically cutting emissions from its current diesel bus fleet.

Clean air can't move forward if corporations aren't willing to invest in the new technologies and infrastructure to get us there. CR&R, a local waste hauler, has invested over \$55 million to make the first major renewable natural gas bio-digester project in California a reality. Likewise, BYD is attempting to move into the transit bus space by producing several electric bus options that could one day help transform mobility to a zero emission future. The result: California now has a greater supply of an ultra-low carbon heavy-duty transportation fuel and another clean option for transit properties to replace diesel.

Last but certainly not least, California wouldn't be the world leader in the fight against climate change and air pollution if it wasn't for leaders like Sandy Berg. During her 13 years at the California Air Resources Board, she has supported and overseen some of the most ambitious climate programs in the country. Likewise, her work to improve our environment extends well beyond her governance role: her company – Ellis Paint – was among the first to move toward a low VOC paint product that can also be recycled.

As the world's eighth largest economy, California's choices matter and those choices are leading the way for the rest of the nation. Through effective public policy and practical business solutions, we will improve air quality, protect public health and prevent climate change. Our honorees deliver solutions in the fight for cleaner air and climate change mitigation, and we applaud them for their vision and leadership.

This event is made possible each year by the generous support of our sponsors, advertisers and guests, and the dedicated work of our board, staff and volunteers. I would like to thank you for all that you do to help make the Coalition for Clean Air the most effective air quality advocacy voice here in California.

JOSEPH K. LYOU, PH.D.



Dr. Joseph K. Lyou believes everyone has the right to breathe clean air. He has worked for more than 25 years to improve public health and environmental conditions in California's most polluted and disadvantaged communities. Dr. Lyou serves as President and CEO of the Coalition for Clean Air, a state-wide organization dedicated to restoring clean and healthful air to all of California. He advocates for effective public policy and practical business solutions that reduce air pollution, protect public health, and prevent climate change.

Since 2007, Dr. Lyou has also served as the Governor's Appointee to the South Coast Air Quality Management District Governing Board, the public agency responsible for improving air quality for more than 16 million people living in Southern California. Dr. Lyou founded the California Environmental Rights Alliance in 2003 and served as Executive Director through August 2010. He previously held management positions with the California League of Conservation Voters Education Fund and the Committee to Bridge the Gap.

He received his Ph.D. from the University of California Santa Cruz in 1990.

ANTELOPE VALLEY TRANSIT AUTHORITY LEADERSHIP IN GOVERNMENT AWARD

The Antelope Valley Transit Authority (AVTA) provides transit service to residents throughout the Antelope Valley and the surrounding regions. The AVTA is headquartered in Lancaster and serves a population of nearly 450,000 residents within a 1,200 square mile area. The AVTA provides over 3.6 million trips annually though a combination of local transit service in the high desert region and commuter service providing trips into downtown Los Angeles, the San Fernando Valley and West Los Angeles. In February 2015, the AVTA made a bold commitment to transition 100% of its fleet to green technologies by 2018. The AVTA will purchase up to 85 electric buses from BYD, the world's largest electric vehicle manufacturer. AVTA is expected to have 50 all-electric buses in service by the end of 2017. The benefits of AVTA's fully zero emission future will prove transformative to local public transit service in and around the Antelope Valley.

Len Engel is the Executive Director of the Antelope Valley Transit Authority (AVTA).



Len Engel joined AVTA in 2012 as the Director of Operations and Maintenance, which included oversight and direction in all activities of the operations, Mmaintenance, and IT departments. With the previous executive director's departure in January of 2015, Engel was charged with actively overseeing the day-to-day operations at AVTA, and named Executive Director in June of 2015.

Throughout his 40-year career, Engel has held numerous executive management and business development positions in public transit for both local governments and the private sector. Prior to his role at AVTA, Engel served as Vice-President and Chief Operating Officer at Southland Transit, Vice-President and Chief Technical Officer at Horizon Internet Solutions and Vice-President, Marketing at Laidlaw Transit Services.

He is a current member of the California Transit Association (CTA) Executive Committee, the Chairman of the CTA Small Operations Committee and a member of the American Public Transit Association (APTA) Small Operations Committee.

Engel has a Bachelor's Degree in Urban Studies from California State University Stanislaus and has completed graduate work in Urban and Regional Planning and in Public Administration.

SANDRA BERG LEADERSHIP IN GOVERNMENT AWARD



Sandra Berg is a proven leader with experience serving on private, public policy, and nonprofit boards. As Chief Executive Officer of the Berg Family of Companies, Past Chairman of the Board of American Coatings Association, and Vice Chair of the California Air Resources Board, Ms. Berg's leadership has successfully combined two worlds that are often seen as oil and water – the chemical industry and air quality public policy. Berg Family of Companies has two cornerstone businesses: Berg Lacquer Company a specialty paint manufacturer and Pacific Resource Recovery Services, an EPA permitted Treatment Storage and Disposal Facility that recycles paint related waste streams. Ms. Berg's innovative leadership, proactive compliance and community outreach have been key elements which set both Berg Lacquer Co. and Pacific Resources apart from their national and international competition.

In 2004, Ms. Berg was appointed to the California Air Resources Board by Governor Arnold Schwarzenegger and reappointed by Governor Brown. Combining her business acumen and community involvement, Ms. Berg brings a practical perspective to the Board. In Ms. Berg's capacity as a Board Member, she has chaired several committees overseeing ARB's incentive funding and facilitated key policy implementation groups, while always emphasizing the need to protect public health and the environment while also keeping business strong. Recent Victories

Your support makes our work possible. Together we recently accomplished the following clean air goals:

- Conceived and led successive campaigns to pass SB 535 (De León) and AB 1550 (Gomez, 2016), which ensures climate investments benefit disadvantaged communities overburdened by air pollution and climate change.
- Established CLEAR, a network of air quality monitors that make air quality personal by showing it at the neighborhood scale in real time.
- Led a multi-year campaign with our partners that resulted in Governor Brown issuing the Executive Order on Freight (2015), which will transition California to adopt zero and near-zero emission technologies in the freight sector.
- Co-sponsored SB 1275 (De León, 2014) which established the Charge Ahead California Initiative to put one million electric vehicles on California roads and ensure that low-income Californians benefit equally from the transition to a clean transportation sector.
