A Simple Solution To Save Lives

The California Smog Check program removes 400 tons of pollution from the air each day. This doesn't even consider the countless older-model vehicles the program has helped retire. When it comes to fighting air pollution, few programs can match the success of smog check.

You might be surprised that heavy-duty trucks, which are responsible for over half the dangerous pollutants coming out of tailpipes, are exempt from this program. Poor performing, gas-guzzling, asthma-inducing trucks get a pass while we all participate.

Does this make any sense to you?

It doesn't to us, which is why it will be one of our highest priorities for 2018.
