The Rules of the Coalition for Clean Air raffle are set forth below. By purchasing a raffle ticket, the purchaser agrees to be bound by these rules and regulations. Coalition for Clean Air's interpretation and application of the rules and regulations shall be final.

### GENERAL RULES

Tickets are \$20 each, 3-packs for \$50, or 7-packs for \$100. Only one method of payment, one name, and one mailing address are permitted per ticket pack. Only one eligible person may be entered in the raffle per ticket sold. If the name of more than one person is submitted with a ticket purchase, and that ticket is selected as a winning ticket, then the person named first will be deemed the holder of record of that ticket and declared the winner. Coalition for Clean Air reserve the right to reject any entry form that is submitted with payment that does not constitute "good funds." Defective or physically altered entry forms may be disqualified from participation in the raffle drawings by Coalition for Clean Air in their sole discretion.
